Delivering Top Quality Education Locally — NSCG's Relentless drive for Excellence

So much has happened at Stafford College since 2015—it is such a great example of a local organisation that has relentlessly followed a path of continuous improvement and striving for perfection—the best it can be, for the benefit of all its students.

Admittedly at that time, the College had some well documented issues including an OFSTED rating of 'Inadequate' - the lowest possible rating.

In the space of seven years the College has merged with Newcastle College, strengthened the leadership and management teams and brought in A Level syllabuses, amongst other things.

At the most recent OFSTED back in November 2019, it was the only College Group at the time to be rated 'Outstanding'—the highest possible rating—under the new framework and the only College Group to be rated 'Outstanding' in every category in the last ten years.

The impact on students is that their exam results have improved by in excess of 10% and there is a specific focus on English and Maths attainment. Student numbers have also gone up as young people react to the breadth of courses available and the quality of all round education on offer.

During this time, the College has invested £10m in general infrastructure a further £3.5m in the STEM (Science, Technology, Engineering & Maths)

Centre that opened in August 2017 and has recently broken earth on the Skills and Innovations Hub investment.

This latter development, replacing the Broad Street and Earl Street buildings is to open in June next year at a cost of £28.6m.



Overall that is some investment in the future learning and development of our young people.

This is the first project of its kind with the Department for Education running the contract directly and I am sure that this will be an exemplar within the Further Education sector.

Road Closure impact reduced

Whitgreave Lane closed for seven months

The closure of any road junction can be extremely disruptive, but when it is the main road into and out of a community and the closure is planned for fourteen months then the impact can be severe to those residents living there.

So when the County Council announced that the Whitgreave Lane junction with the A34 north of Stafford was to close originally in February 2022, for fourteen months there was significant concern in the village. The other route into Whitgreave had been the source of significant flooding over recent years and some of the road surface had deteriorated significantly.

When Royal Mail removed collections from the post box in the centre of the village, it must have felt like all services were being removed with the village isolated and cut off.

Following discussions with County Highways and the developers, the roadworks were able to be re-phased such that the planned closure could be reduced from 14 months to 7, with a phased re-opening of the lane to traffic. Additionally significant carriageway repairs were undertaken, with pot hole filling, edge of carriageway failures re-instated and a general surface dressing of the lane applied.

Works were also undertaken to identify the source of the carriageway flooding, with land drains re-introduced, silt removed from a critical drainage pipe and root ingress removed, such that the flooding experienced should now be a thing of the past.

Royal Mail, when contacted, also re-introduced their daily postal collections in the village.

So whilst the seven months of road closure will, I am sure, be highly disruptive to local residents many of the man-made hazards that they might have faced have either been removed or reduced as far as possible.

Newport Road Pavements resurfaced with new compound

Sometimes new and innovative solutions are the only way to get things delivered

With money for Highways increasingly scarce, then new ways of finding solutions for carriageway and pavement repairs can often be necessary. Following three and a half years of trying to get the pavements on Newport Road in Eccleshall resurfaced without success and as the

pavements continued to deteriorate, a new approach needed to be adopted, just at the time the County Council started to test out a new resurfacing material.

By volunteering to be a test site and early adopter of this compound, a way has been found to bring forward the repair of these pavements and this was undertaken in March of this year. Now let's see what we can achieve elsewhere.

Highways Safety—a priority for all road users on Beaconside

Essential Road Works don't need to come at a safety cost

Essential infrastructure works need to be undertaken by the statutory providers, and their impact often causes a lot of disruption to many people. However learning and reacting quickly to issues can reduce that impact.

Such was the case at Marston Grange, where Severn Trent, on behalf of two housing developers wanted to link into the foul sewer running underneath the A513 Beaconside Road in Stafford, which services the 500 odd homes now on Marston Grange but also forms part of the arterial road that rounds along the top of Stafford.

So when the first iteration of temporary road layout was introduced that removed a vital set of pedestrian traffic lights that allowed children to cross between Marston Grange and Parkside and potentially allowed two streams of traffic to use the same lane at the same time by not following the relevant directional flows, it was clear that a new scheme needed to be implemented—and quickly.

Whilst this new scheme—introduced in a day—resolved one set of problems it created a huge delay at peak periods for householders trying to get off the Marston Grange estate.

Recognising this, the next day the length of time the lights for Marston Grange traffic only could flow through the road works was increased with that reducing the delays from thirty five minutes to a more acceptable ten, without impacting significantly on other road users.

Whilst it is not great to be delayed in traffic at any stage, looking at ways to optimise the flow and reduce the delay as far as possible can at least demonstrate that individuals concerns are being listened to and acted upon—in a fast reactive way.

Beaconside Road Widening works will happen this Autumn

Disruptive Roadworks combined to reduce overall impact

Road widening works to the A513 Beaconside Road in Stafford were planned at the time of the development of the Marston Grange housing estate some six or seven years ago.

As the estate has been developed out the year long scheme has been consistently delayed. Such that the volume of traffic now using the Redhill roundabout has reached capacity, without installing a signalised roundabout to improve the flow. These works will also take approximately a year to complete.

Rather than inflict two years of delays on road users in that area, the plan is to undertake the works together, accepting that the impact will cover a slightly wider area but be over a more

concentrated period. The current start date for these works is Autumn 2022 and represents an investment of over £5m in local infrastructure.

Significant Funding secured for Homelessness Support

Stafford Borough has long been seen as an innovator when it comes to its work to reduce street homelessness, whether it be in being reference in the House of Lords for its Housing First work or in being the first NPSS 'Gold Standard' Housing Authority in the whole of the Midlands.

One of the things the Housing team have done is to set up many new and innovative partnerships covering roles like the Community Matron—also known as 'the Angel of Stafford'. Its latest partnership is one of creating a co-ordinated approach to homelessness with the mental health services, as well as drug and alcohol services, as the individuals being seen have more and more complex issues.

The Housing team have recently secured over £650,000 to set up amongst other things supported accommodation to house five long term rough sleepers and provide them with the support needed to get them back into stable sustainable housing for the long term.

Continued focus on reducing homelessness in Stafford Borough will see the introduction of supported accommodation as part of £650,000 being spent in the Borough, which has been secured from central government - in a 'a names not numbers' approach

Housing Options in Stafford

If you are homeless, face losing your home in the very near future (or in the next three to six months) or if you have to rethink your housing options because of a change in your circumstances.



The work, alongside charity, Humankind, started in the Autumn of last year and will be fully rolled out during the Spring and Summer of this year.

Stafford in the World returns after a two year absence

Stafford in the World was set up by the then Member of Parliament for Stafford, Jeremy Lefroy, as a celebration of Stafford's international links—many of which are not ordinarily seen or talked about and covers both local businesses as well as voluntary sector organisations. Local Government Funding & Planning Policy discussion

Lobbying for the changes we all know need to happen

So at a recent meeting with the Secretary of State for Levelling Up, Housing and Communities, the Rt. Hon. Michael Gove MP, the discussion covered amongst other things the local government settlement as well as the need to build carbon neutral housing as a simple planning policy principal.

There is little point after all in building any new homes that within the matter of a few years will need to be retro-fitted to save energy and become carbon neutral.

Working together to bring in more funding to tackle joint challenges

Lots is talked about climate change and undertaken to 'keep the 1.5 alive', which was the primary aim of the recent climate change conference in Scotland—COP 26.
